I understand and agree to the following:

The Triangle Youth Ballet is based on an academic year and the enrollment agreement continues through May 30, 2020. If for some reason you must withdraw from the school before May 30, 20120 you must do so in writing by mail or e-mail. There are no refunds or credits for unattended classes. Annual tuition is based on a 36-week course of study. We offer quarterly payment plans for your convenience. Although tuition is not payable by the month, installment plans are available.

Fees and Charges:

There is a \$35 Registration Fee for each enrolling student, valid for the academic year. Alternately, a Membership Fee of \$35 waives the Registration Fee and allows enrollment in any of our classes for the entire family for a calendar year. Other Membership benefits include advance notice of ticket sales and our monthly newsletter. Membership fees, registration fees and tuition are neither transferable nor refundable. Annual tuition is due September 15. Quarterly tuition is due the first week of each quarter. Any account in arrears for more than 30 days will be charged a \$25.00 Late Fine and continued enrollment is in jeopardy. Our Returned Check Charge is \$35.00.

Attendance/Tardiness:

Students are expected to attend all classes on time. Missed classes may be made up during the academic year. See your teacher for a recommended class.

Prompt Pickup:

Students should be picked up promptly after their class. It is understood that the Triangle Youth Ballet and or its agents will not be responsible for any supervision other than the dance class or rehearsal time. A late pick-up fee schedule will be sent to parents who are not prompt in picking up their dancers.

Inclement Weather Policy:

If hazardous weather conditions cause the Triangle Youth Ballet to cancel classes or close early, announcements will be on our web site homepage, on our outgoing phone message and on the Triangle Youth Ballet's Facebook page.

Showcase Week:

In the last week of each quarter, families and friends are invited to observe classes. Check the message center for dates and times. Additional visits may be arranged with instructor.

Code Of Conduct:

Dancers are expected to arrive on time and properly dressed for class. Everyone should behave in a polite and respectful manner. The faculty believes dance is best taught in a warm and supportive environment and every dancer has a responsibility to contribute to this goal.

Photographic Release:

The Triangle Youth Ballet shall have the right to use a photograph, videotape, voice or other likeness of the dancer in promotional, publicity or commercial advertising purposes and that these reproductions are the sole property of the Triangle Youth Ballet.

Medical Information:

Any information regarding the medical history of the dancer, of which you feel we should be aware, should be submitted in writing. (For example: asthma, allergies, medications, history of joint or muscle pain, etc.)

RELEASE:

As additional consideration for the student's instruction, the undersigned hereby releases and holds harmless the Triangle Youth Ballet and/or any of its agents or representatives from any liability whatsoever arising out of injury to the person or the property of the student which may occur while participating in the activities of the Triangle Youth Ballet or its affiliated Company. The undersigned further agrees to indemnify the Triangle Youth Ballet in the event any claims are asserted against it arising from the student's participation.
